



TERMS AND CONDITIONS OF SALE

PAYMENT DUE:

Invoiced amount is due and payable in full within thirty (30) days of date of invoice unless otherwise stated on individual invoice.

SPECIAL ORDERS:

Special Orders may require a deposit when order is placed. All Special Orders are *Non-returnable*.

SERVICE CHARGE:

A Service charge of \$50.00 will be applied to any returned check. A rebilling service charge of 2% per month on the unpaid balance will be assessed on all items not paid when due.

COSTS OF ENFORCEMENT:

If the buyer fails to carry out any of these Terms and Conditions of Sale, including failing to make any payment when due, AMOFIND may recover all expenses incurred in enforcing our rights under these Terms and Conditions, including collection costs, attorney fees, and interest to the maximum extent permitted by law, in addition to any other relief that may be proper.

VENUE:

These Terms and Conditions of sale will be construed under and governed by the laws of the State of Indiana. The buyer agrees to submit any dispute relating to these Terms and Conditions or to the products sold hereunder to the Porter County, Indiana Court of Common Pleas.

MINIMUM ORDER:

Orders less than \$50.00 will be charged an additional \$5.00, which does not include delivery.

RETURNS:

Stock items are subject to a \$25.00 or 10% (whichever is greater) restocking charge. All returns shall be in un-used "New" condition.

Non-stock items are subject to the return policy of the manufacturer.
